Competition Regulations

Classifications - The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event. Classes will be offered for breeds and varieties and divided into Groups as described in Chapter 3, Section 1 of the Rules Applying to Dog Shows and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. The Miscellaneous class competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. The FSS competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.

Entry and Eligibility - Entry and eligibility requirements include: The Four-to-Six Month Puppy event may be offered at licensed or member dog shows at the option of the show giving club. • Four-to-Six Month Puppy Competition must be listed in the premium list, entry form and judging schedule, if offered. AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows. A foreign-born dog may enter this class if they are registered in the country of origin. FSS number or FSS registered litter number will be required for Miscellaneous and FSS breed entries.

All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol. Professional handlers are not permitted to exhibit in this class. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay.

Titles - The Certificate of Merit (CM) title is an introductory title to AKC conformation events. Entrants in each breed shall compete for Best of Breed and Best of Opposite Sex to Best of Breed. Winners of the Best of Breed in each of the individual breeds or varieties will be awarded points toward the CM title based on the number of dogs defeated in their breed or variety. Winners of Best of Opposite Sex to Best of Breed in each of the individual breeds or varieties will be awarded points toward the CM title based on the number of dogs defeated in their sex. Group winners will be eligible for the highest number of points earned by any breed within that Group. Best Four-to-Six Puppy in Show will be eligible for the highest number of points earned by any breed entered.

The Certificate of Merit requires 15 points awarded in accordance with the following points structure.

Dogs Competing Points

2 Entries – 1pt; 4 Entries – 2pt; 8 Entries – 3pt; 12 Entries – 4pt; 16 Entries – 5pt

Best 4-6 Puppy in Specialty - Orange

Best of Opposite Sex – Lavender

BEST OF BREED COMPETITION

“The following categories of dogs may be entered and shown in Best of Breed competition. Dogs, which according to their owner’s records have completed the requirements for a championship but whose championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a championship according to the owner’s records. If at the end of the 90-day period, the championship of a dog has not been confirmed by the American Kennel Club, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by the AKC.”

BEST PUPPY

After Best of Breed judging the winner of each Puppy Class will compete for Best Puppy. Any entry in the puppy classes that is awarded Best of Breed or Best of Winners would automatically be Best Puppy. Only dogs not defeated in a puppy class are eligible for Best Puppy competition.

BRED BY EXHIBITOR

The person handling the dog must be a breeder of record of the dog and an owner of record of the dog. Family members must be both a breeder and owner of record to exhibit in the class. Any entry in Bred-by-Exhibitor classes that is awarded Best of Breed or Best of Winners would automatically be Best Bred-by-Exhibitor.

Regular Classes

NOVICE - This class shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the times of entries close have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

OPEN - This class shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, who have won 3 first place awards in a Novice Class in a licensed or member show, with competition present. The winner of a Novice Class shall automatically become eligible, upon notice to the Open Class ring steward, to enter and compete in the Open Class at the same show provided the win is the (3rd) first place award with competition and further providing there are one or more Junior Handlers competing in the Open Class.

MASTER- This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 first place wins in an Open class with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

BEST JUNIOR HANDLER: The Junior Handler placed first in each of the regular Junior Showmanship Classes, if undefeated in any other Junior Showmanship Class at that show, shall automatically be eligible to compete for this prize.
